# Proposed Wheelchairs (Short-term access) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure the provision of wheelchairs to anyone assessed as needing one on a shortterm, as well as on a long-term, basis. The consultation runs from 8 April 2019 to 30 June 2019. All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey.
